Student Training & Advocacy Mentoring Partnership (STAMP)

Realizing the great impact that mentors have on students, The Foundation has implemented the Student Training & Advocacy Mentoring Partnership (STAMP). STAMP is a program that offers students the opportunity to achieve success by providing them college and career planning resources and volunteer mentors to give students assistance, guidance, motivation, and accountability to work hard and to ensure they graduate from high school to continue their education either through technical training or earning a college degree. It is a multi-year commitment for at-risk high school students to invest in their future and increase the high school graduation rate and post-secondary educational opportunities.

The STAMP program strives to accommodate eligible students, match them with mentors, and assist them in acquiring scholarships and grants to cover the cost of attending college or other post-secondary training. Students and their families, mentors, school coordinators, and Foundation staff all work together through the STAMP program and are instrumental in helping students pursue their post-high school education and career goals. Students will also be able to attend STEM@work events to learn about local businesses.

ASHRAE Sends Two Letters of Support to Align Federal and State Refrigerant Laws

On October 25 and October 31, ASHRAE sent letters to the Wisconsin House Environment Committee and to New Jersey Governor Phil Murphy respectively to advocate for legislation in both states that would align federal and state refrigerant laws. WI AB 339 and NJ AB 5165 both will align their state's refrigerant regulations with what is recommended by the federal government. Current federal law provides that, to the extent practicable, certain ozone-depleting substances must be replaced by chemicals, product substitutes, or alternative manufacturing processes that reduce risks to human health and the environment. The U.S. Environmental Protection Agency is required to promulgate administrative rules identifying acceptable alternatives to these ozone-depleting substances. These bills both legislate that no state agency and no local governmental unit may prohibit or limit the use of a refrigerant that the EPA has designated as acceptable for use. This will create a clear regulatory framework in Wisconsin and New Jersey and will allow for better alignment with ASHRAE Standard 15-2022, Safety Standard for Refrigeration Systems and ANSI/ASHRAE Standard 34-2022, Designation and Safety Classification of Refrigerants. ASHRAE Pens Letter of Support to Senate Committee in Support of the Pro Codes Act

On November 3rd ASHRAE sent a letter to the United States Senate Committee on the Judiciary to express our strong support for S. 835, the Pro Codes Act. The Pro Codes Act affirms the importance of Standard Development Organizations (SDO) and the cost-effective and efficient process by which these standards are used by governments. The Pro Codes Act also legislates that SDOs whose codes and standards are incorporated by reference into law retain copyright control over their codes and standards provided that a copy of the code or standard in question is available for free online. This important legislation would help protect ASHRAE's intellectual property and raise awareness of the crucial standard development work that ASHRAE undertakes.
